North—From Tawa Dam Right Bank to North East-North and North-Eastern outer boundary of water spread of 1166 contour of Denwa Lake, Northern and North-Eastern boundary of Comptt. No. 392, 393 and 467 upto Nagdwani River, Northern boundary of Comptt. No. 480 and hilly ridge and Nos. situated on the North of Comptt. Nos. 48, 487 and 484 and 485.

East—Eastern boundary of Comptt. No. 485 in East and Southern boundary of Comptt. No. 237, 23 connecting Western Pugura village with N.E. and artificial line. Further along Tar road upto Pachmarhi connecting the Northern boundary of Pachmarhi Area Development Authority consisting of Eastern boundary of Comptt. 240, 267 and 266 and Southern boundary of Comptt. No. 266 further along the Western and Southern bound-

ary of Pachmarhi Area Development Authority, along Eastern boundary of Comptt. No. 313, 310, 309, 307 and Northern boundary of Comptt. No. 303 and 302 further along Public Works Department New Tar road leading to Mahadeo and further ahead along Bridle path going to Namalia connecting to Birja nala finally connecting Chhindwara District boundary passing through Comptt. No. 303 and 252 and along Eastern boundary Comptt. No. 253.

South—From the point inter-section of Birja nala with Chhindwara District boundary to the West along the said District boundary up to South-Western corner of Comptt. No. 256 further towards North along the Western boundary of Comptt. No. 256 and 257; along Northern boundary of Bori range in Southern boundary of Comptt. No. 483, 479, 478, 477, 473 and 472 of Piparia and Sohagpur range Eastern boundary Comptt. No. 86 and Comptt. No. 87, 95, 96, 97 and 98 Southern and Western boundary of Comptt. No. 98 of Bori range, Southern and South-Western boundary of Comptt. No. 215 and 216 Madhya Pradesh State Forest Development Corporation Kesla Project, South-Western boundary of Comptt. No. 237 of Bagra range, Northern boundary of Comptt. No. 218, 219 and 220 North-Western boundary of Comptt. No. 222 Western and Northern boundary of respective Comptt. No. 197, 193 of M.P.S.F.D.C. Corporation Kesla Project crossing Tawa Reservoir Southern boundary of Comptt. No. 351 along which roughly the route of motor boat of M.P.S.F.D.C. Kesla Project is traversed to cross the Tawa Lake.

West—From South-West corner of Comptt. No. 351 of Hoshangabad range to the North all along North-Western outer 1:66 contour boundary of Tawa Lake running through the Comptt. No. 352, 353, 357, 353, 360, 361, 352, 370, 373, 375, 376 and 377 of Hoshangabad range up to Tawa Dam left Bank.
